INFORMATION WE MAY COLLECT FROM YOU

We may collect and process the following data about you:

- Information you give us: you may give us information about you by filling in forms on our site or by corresponding with us by phone, e-mail or otherwise. This includes information you provide when you subscribe to our service, search for products or services, place an order on our site, participate in discussion boards or other social media functions on our site, or other activities commonly carried out on the site and when you report a problem with our site. The information you give us may include but not be limited to your name, address, e-mail address and phone number, personal description and photograph.
- Information we collect about you. Regarding each of your visits to our site we may automatically collect the following information:
- Technical information, including the Internet protocol (IP) address used to connect your computer to the Internet, your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform;

- Information we receive from other sources. We may receive information about you if you use any of the other services we provide or any other websites we operate. We are also working closely with third parties (including, for example, business partners, sub-contractors in technical, payment and delivery services, advertising networks, analytics providers, search information providers, credit reference agencies) and may receive information about you from them.
- Information you post on the request forms to be processed by our vendors.

USES MADE OF THE INFORMATION

We use information held about you in the following ways:

We may share your information with selected third parties including:

- Users of the service, business partners, suppliers and sub-contractors for the performance of any contract we enter with them or you.

We may disclose your personal information to third parties:

WHERE WE STORE YOUR PERSONAL DATA

The data that we collect from you may be transferred to, and stored at, a destination outside the European Economic Area ("EEA"). It may also be processed by staff operating outside the EEA who work for us or for one of our suppliers. Such staff may be engaged in, among other things, the fulfilment of your order, the processing of your payment details and the provision of support services. By submitting your personal data, you agree to this transfer, storing or processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.

All information you provide to us is stored on our secure servers. Any payment transactions will be encrypted using SSL technology. We ask you not to share a password with anyone.
